1. Election of Chairman The Vice-Chairman, Mr. S. Stracey took the chair and thanked Mr. Dunn for his knowledgeable work as Chairman over the past year, particularly in respect to the workload in connection with the Stonor Arms applications. Mr. Stracey then proposed that Mr. Dunn be elected as Chairman for the forthcoming year, seconded by Mrs. D. Newell and carried unanimously.
Mr. Dunn signed the Chairman's Declaration of Office form.
2. Election of Vice-Chairman Mr. Dunn thanked Mr. Stracey for his assistance as Vice-Chairman over the past year and also thanked all his colleagues on the Parish Council for their committed work. Mr. Dunn proposed and Mr. Godfrey seconded that Mr. Stracey should be elected as Vice-Chairman for the forthcoming year; carried unanimously.

- b) The Clerk presented details of a competitive quotation for Parish Council insurance received from Came & Company (Aviva Policy). After discussion it was agreed that the quotation from Aviva be accepted, and the Clerk was to write to Aon to decline their offer. Cheque drawn for payment of premium. PP
 - c) Registration of Parish Council as an Employer: This was fully discussed; the Clerk confirmed that her tax had been paid up to September 2011 and it was therefore agreed that she should write to HMCE pointing this out and requesting exclusion from the registration on the grounds that the Clerk is the only Parish Council employee and has been responsible for self-employed tax payments, as confirmed in writing from HMCE previously. To be brought forward. PP
 - Prior to registration as an employer, the Parish Council should put in place an official contract of employment for the Clerk and a specimen example was discussed at the meeting.
 - d) VAT remittance not yet received - Clerk has written to HMCE and Barclays Bank, replies awaited.

9. Roads
- a) Blocked grips of B480 between Stonor and Middle Assendon No action has been taken by OCC and water is still flowing out from one drain, crossing the carriageway and going into another drain further down the road. The gullies have been emptied, but this does not address the problem. Clerk to write again. PP
 - b) Pothole near 'The Lookout', Russells Water. No action taken by OCC, and the verge is being damaged. Clerk to write again. PP
 - c) Pothole near Five Horseshoes. Clerk to contact OCC for this to be dealt with. PP
 - d) Potholes at Lodge Farm Lane, Maidensgrove. Prof. Kempner had contacted OCC Cllr. Mr. Rodney Rose, who had pursued the matter. The lane is badly damaged and OCC have agreed to undertake extensive works in the future. At present, planings are being used as a temporary measure. To be monitored. b/f
 - e) Potholes at Hollandridge Lane Mr. Hunt was thanked for his assistance in dealing with the delivered planings, which are of some assistance. To be monitored. b/f
 - f) 180K Bike Ride, Challenge Henley on Thames, 18th September 2011. The Chairman reported on this event, which has not been fully publicised. The route passes through the Parish, and it is understood that the roads will be closed for the day. The Clerk was instructed to write to OCC to ascertain fuller details; serious concern was expressed that neither OCC nor the organisers have consulted the local community, who are largely unaware of the proposals. - a) Driving on commons Grass kite users again visited the area earlier in the Spring, but the grass is now too long for this activity. No motorised vehicles have been observed recently. b/f

11. Footpaths Report

- a) Vandalised stile FP20/BR22 West end of Long Wood. This has not been repaired. b/f
 - b) Vandalised Gate on PS17. This gate is lying on the ground approx. 200 meters from the junction with PS22. It does not impede the passageway of walkers. b/f

The aim of the website will be to publicise matters of general information, in addition to the official notices currently displayed on the notice board in Stonor.
